President Vaillencourt called the regular meeting of the Manchester Village Council to order at 7:00pm with the Pledge of Allegiance to the Flag. Council members present: Dresch; Vaillencourt; Way; DuRussel and Woods. Council members absent: Andrews and Chartrand. Also present were: Manager Wallace.

PARKS- DuRussel went over the signs for the parks and their last meeting. Discussion was held on memorials on the back of signs. DuRussel will discuss with the Parks Commission and associated groups.

DDA- Vaillencourt reviewed the social district and bringing in district signs on Sunday nights with many merchants being closed.

DPW- Wallace went over current DPW activities touching on Manchester Run, Fair Parade and chipping. Park maintenance items that may need review for the next budget year include Kirk Park and the Shared Use Trail. Extra needs of the DDA were also discussed. It could be reviewed if summer help could be used for some of these items as volunteers should not always be counted on in certain circumstances.

MANAGER-

Wallace reviewed his report highlighting sidewalk work, 134 Adrian St. and the Planning Commission's scheduled review of the Sign Ordinance.
